GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$106, down from \$121 the week of December 18. The FOB Gulf DDGS to corn spread is \$33.28, up from \$20.97 the week of December 18. Overall ethanol production in the United States averaged 1.196 million bpd, up 98,000 bpd versus last week and 101,000 bpd, or 9.2% higher than in the same week last year.

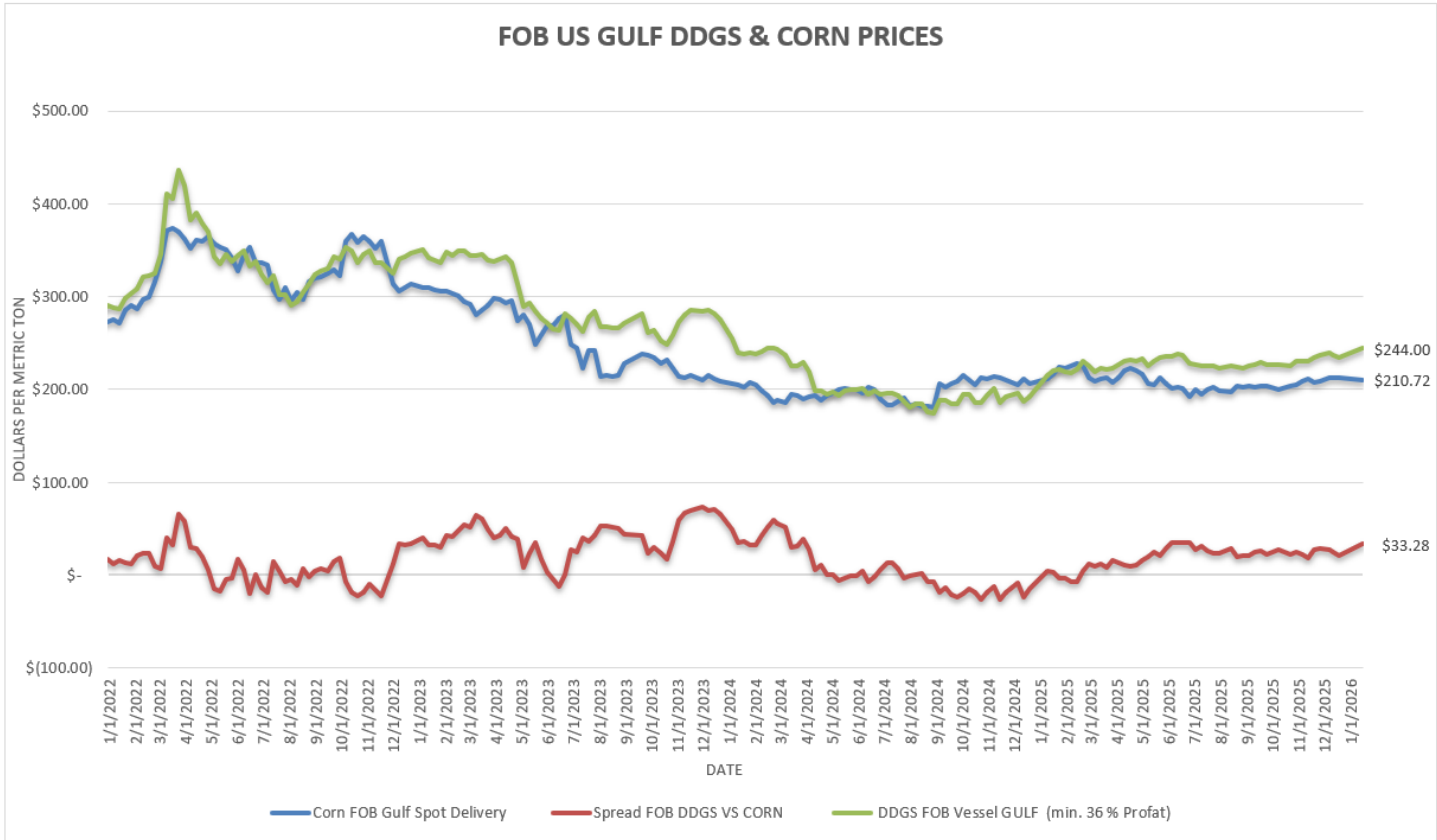
