## GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$101, down from \$103 last week. The FOB Gulf DDGS to corn spread is \$35.78, up from \$30.58 last week. Ethanol production in the United States averaged 956,000 barrels per day (bpd) in the week ended Jan. 30, down 158,000 bpd versus last week and 151,000 bpd, or 13.6%, lower than in the same week last year.

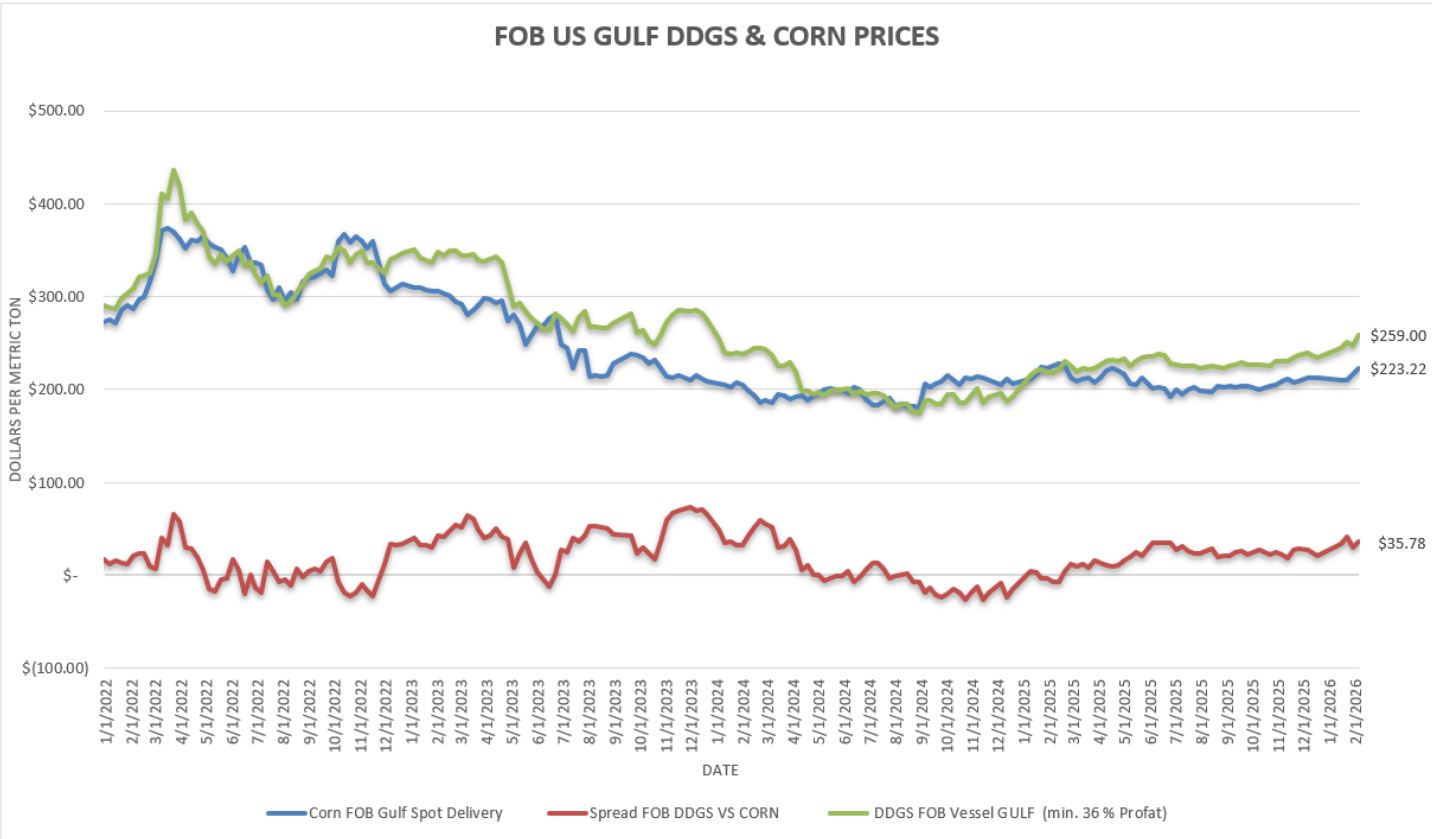
