## GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$125, up from \$106 last week. The FOB Gulf DDGS to corn spread is \$37.73, down from \$44.33 last week. Overall ethanol production in the United States averaged 1.093 million barrels per day (bpd) in the week ended March 13. That is down 33,000 bpd week-on-week and 40,000 bpd, or 3.8%, higher than in the same week last year.

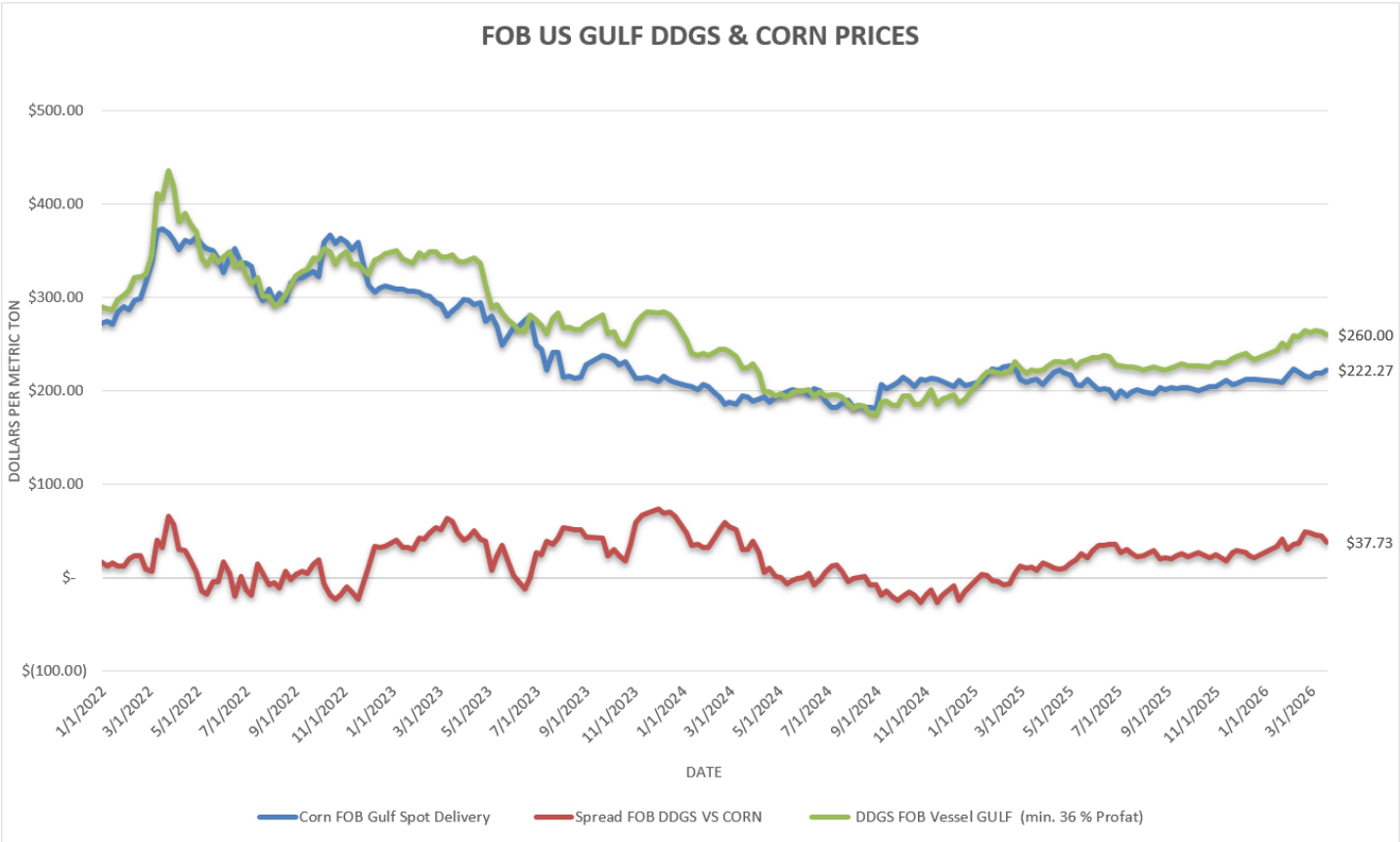
