GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$79, down from \$91 the previous week. The FOB Gulf DDGS to corn spread is \$29.32, down from \$21.41 last week. Overall U.S. ethanol production averaged 1.056 million barrels per day, up 20,000 bpd week-on-week.

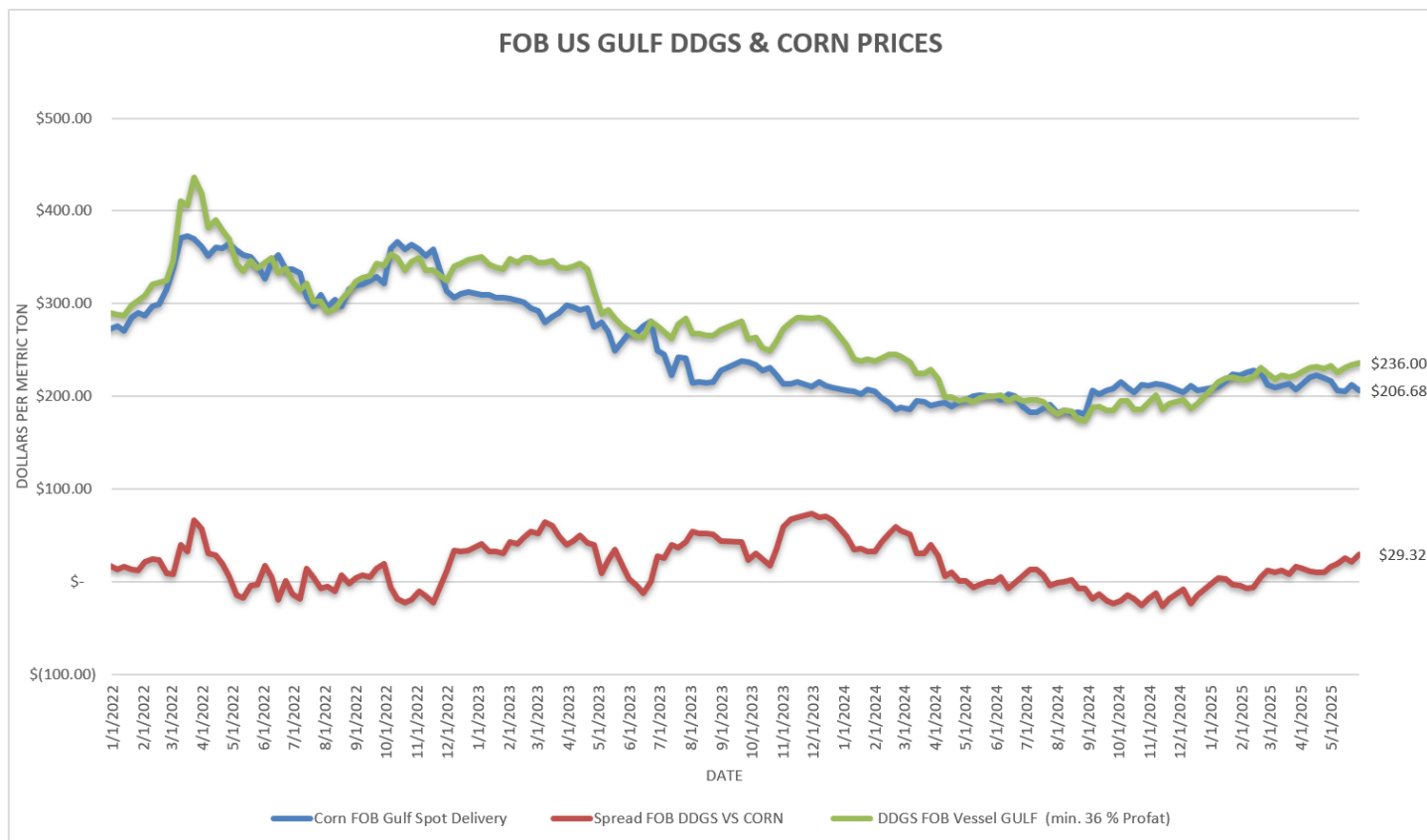
