GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$69, down from \$73 the previous week. The FOB Gulf DDGS to corn spread is \$30.77, up from \$27.04 last week. Overall ethanol production in the United States averaged 1.085 million bpd, up 9,000 bpd week-on-week and 21,000 bpd, or 1.9% lower than in the same week last year.

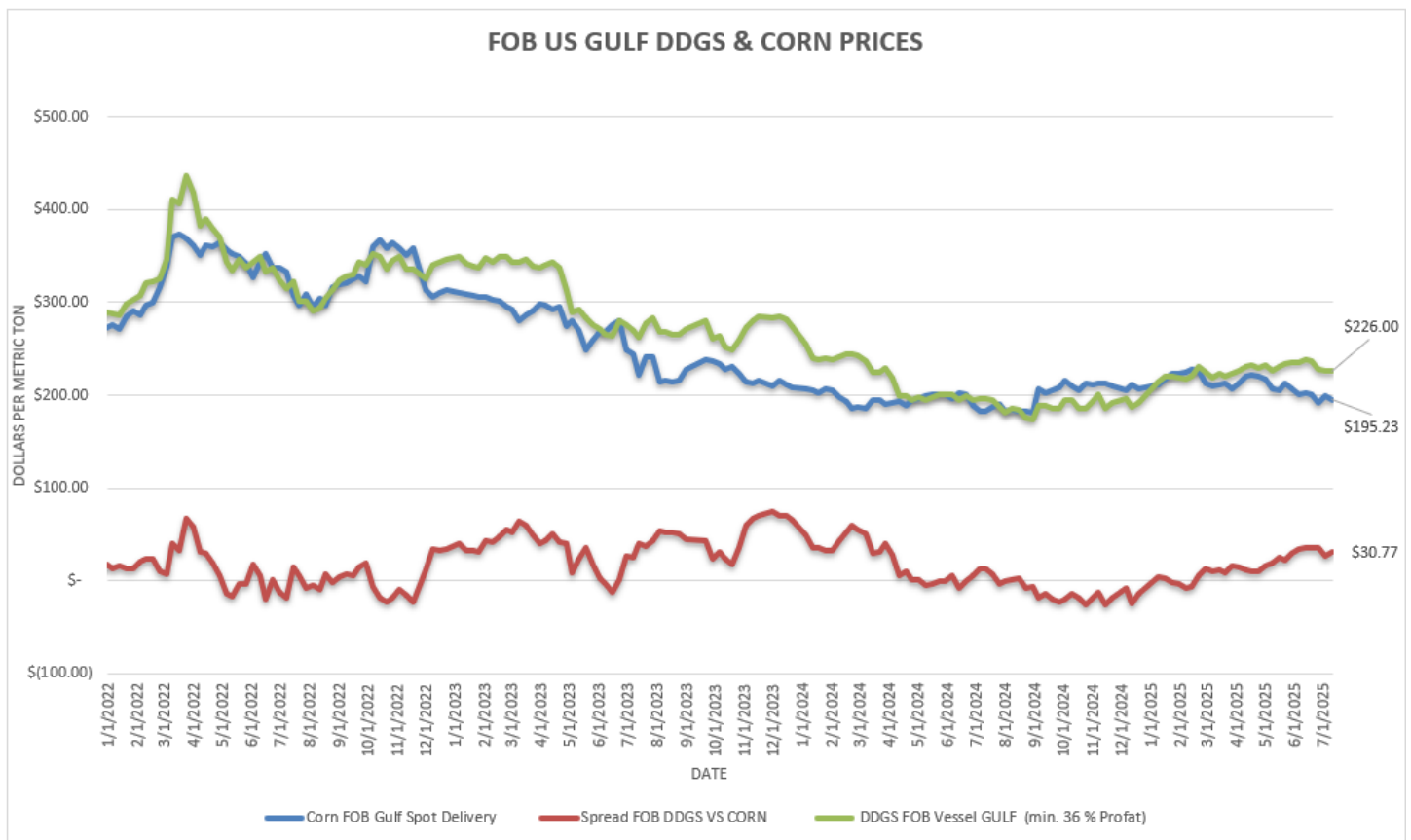
