GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$109, up from \$82 the previous week. The FOB Gulf DDGS to corn spread is \$29.16, up from \$23.93 last week. Overall ethanol production in the United States averaged 1.093 million bpd, up 12,000 bpd versus last week and 21,000 bpd, or 2% higher than in the same week last year.

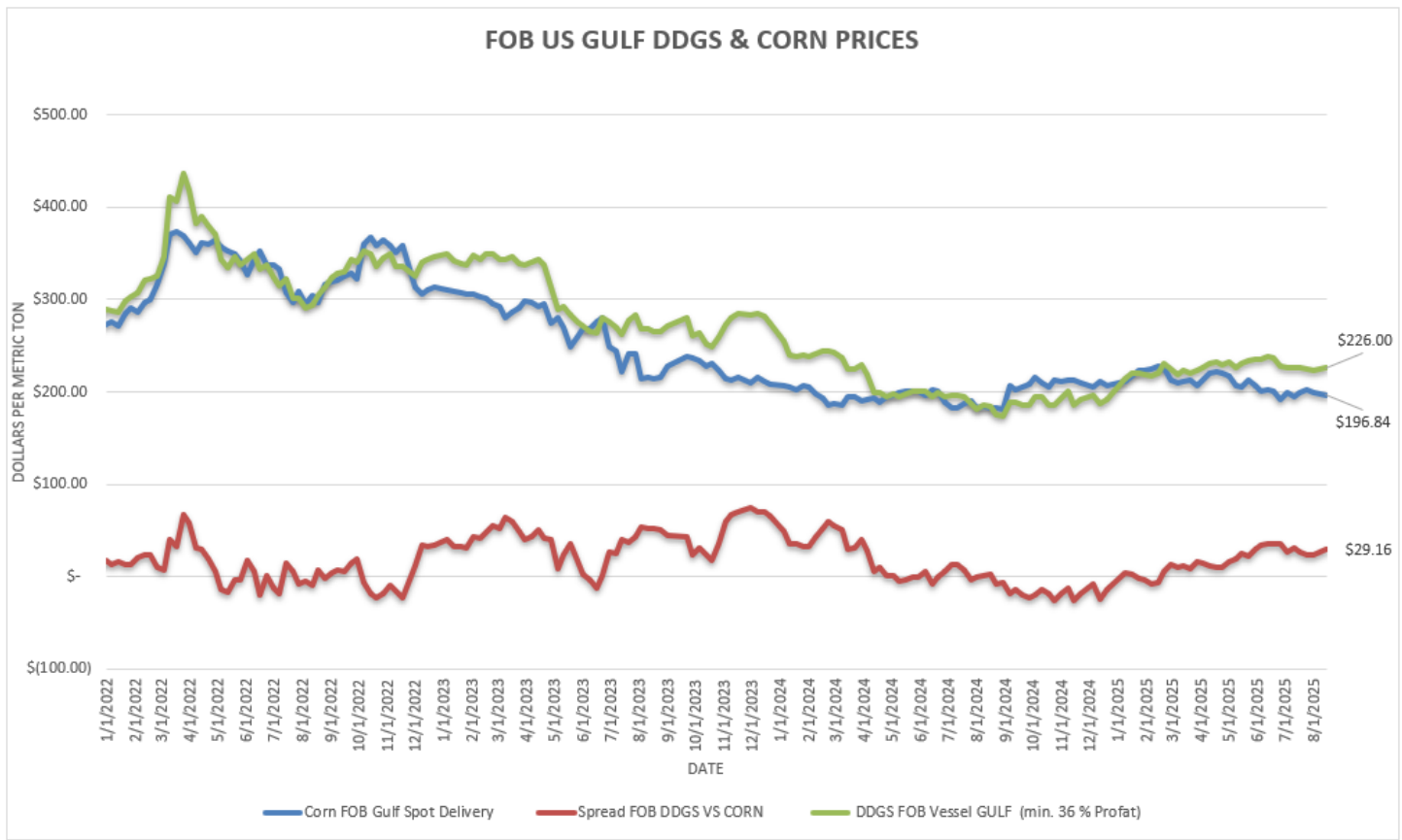
