Market Outlook: U.S. ethanol prices ended last week 2.4 percent higher but retreated in early week trading and fell 3 percent through Tuesday's close. Midwest wholesale rack ethanol prices were higher to end last week and were up 0.8 percent through Tuesday's market close to their last quote of 50.77 cents/liter (192.17 cents/gallon).

FOB Houston ethanol prices finished last week 1.3 percent higher and are up 0.3 percent through Tuesday's trading from Friday's close. FOB Houston ethanol prices are quoted at 49.42 cents/liter (187.07 cents/gallon). FOB Santos, Brazil anhydrous ethanol prices were higher last week; they are up in early week trading, rising 2.6 percent to 58.32 cents/liter (220.78 cents/gallon) through Tuesday's close.

The FOB Gulf-Santos, Brazil ethanol spread has widened from last week's close through Tuesday's trading and is currently at -8.91 cents/liter (-33.71 cents/gallon).

MTBE prices rose 9.2 percent last week but pulled back slightly in early week trading to fall 0.7 percent from Friday's close through Tuesday's trading. MTBE's premium to FOB Houston ethanol has decreased from last week's report and stands at 5.94 cents/liter (22.47 cents/gallon).

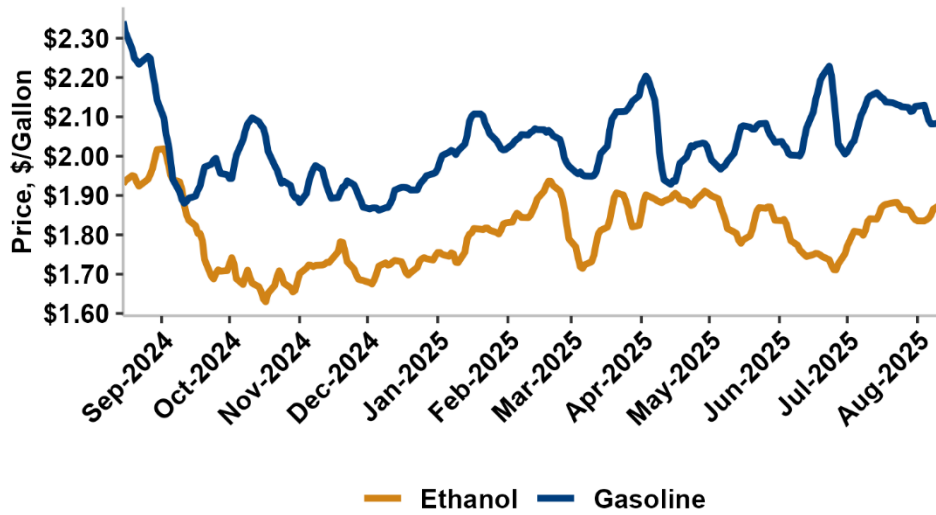
BTX component prices were mixed last week and continued that trend through Tuesday's market close: Benzene was down 2 percent while Toluene was up 0.7 percent, and Xylene was down 0.8 percent. The estimated weighted average aromatic price is currently 74.04 cents/liter (280.28 cents/gallon), down from last Friday's close. The BTX-Houston ethanol spread narrowed last week, and the weighted average BTX price is 24.62 cents/liter (93.21 cents/gallon) higher than the FOB Houston ethanol price.

Gasoline and petroleum products were lower last week and remained mostly so in early week trade. RBOB futures are down 0.3 percent to start the week while FOB Prices for 87 CBOB and 87 conventional gasoline are down 1 and up 0.3 percent, respectively. WTI futures are 1 percent lower at \$63.24/barrel while Brent futures are down 0.5 percent to \$66.24/barrel, from Friday through Tuesday's close.

Liquid tanker rates are 2 percent lower on average this week with offers for Brazil to South Korea seeing the largest gains (up 4 percent). Freight from the U.S. Gulf to the East Coast of Mexico saw the largest declines and is down 16 percent from last week. On average, tanker freight from the U.S. Gulf is down 5 percent this week while freight from the PNW is mostly steady. Liquid tanker freight rates from Brazil are up 2 percent, on average, this week. Freight rates across all origins are 8 percent lower than this same week in 2024.

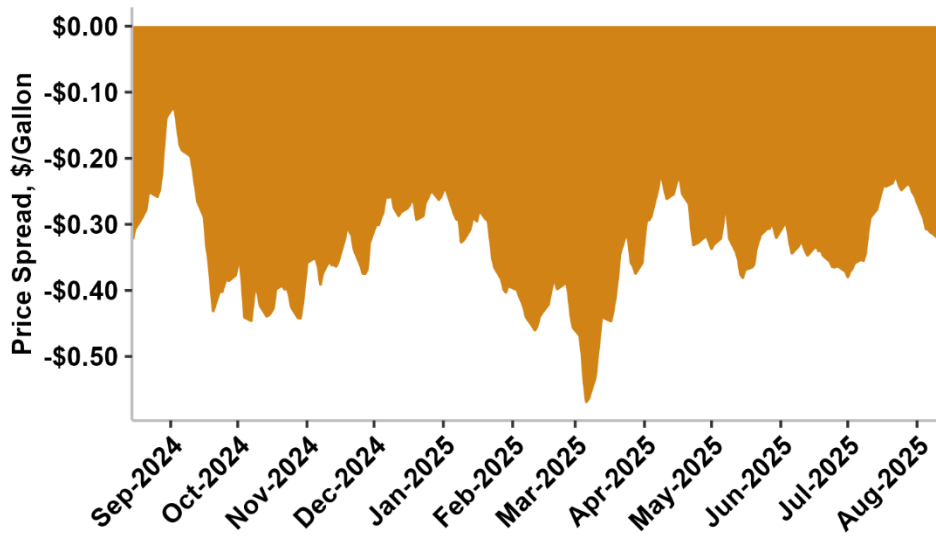
On a cost-and-freight (C&F) basis, offers are mostly higher this week as higher FOB offers for ethanol offset lower freight rates. Prices for ethanol C&F to Central America from the U.S. Gulf are up 0.6 percent this week and are down 3.8 percent from this same week in 2024. Values for PNW ethanol to Southeast Asia average \$728.16/MT this week, down 1.2 percent from the prior week and down 1.9 percent year-over-year. That compares to U.S. Gulf to Southeast Asia C&F prices that average \$690.1/MT and are up 1.2 percent from last week but are down 4.7 percent year-over-year. C&F prices for Brazilian ethanol to Southeast Asia are up 1.7 percent from last week.

Rolling 52-Week Ethanol and Gasoline Prices, FOB Houston



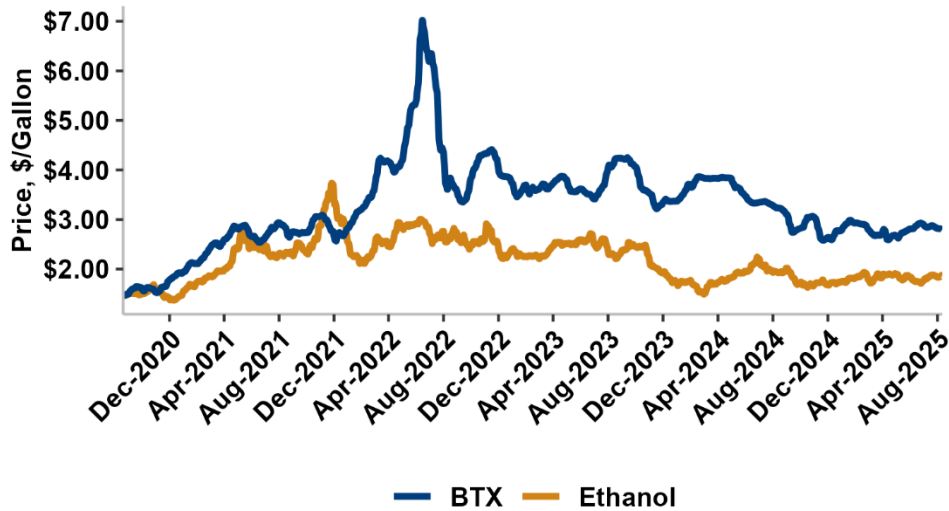

Rolling 52-Week FOB Houston - FOB Santos, Brazil Ethanol Price Spread



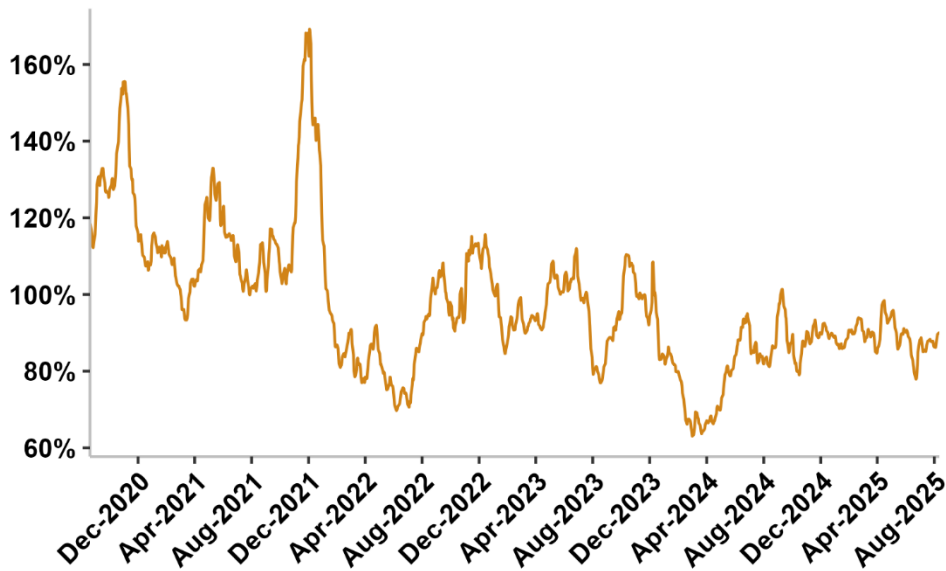

Daily Weighted Average BTX and Ethanol Prices, FOB U.S. Gulf



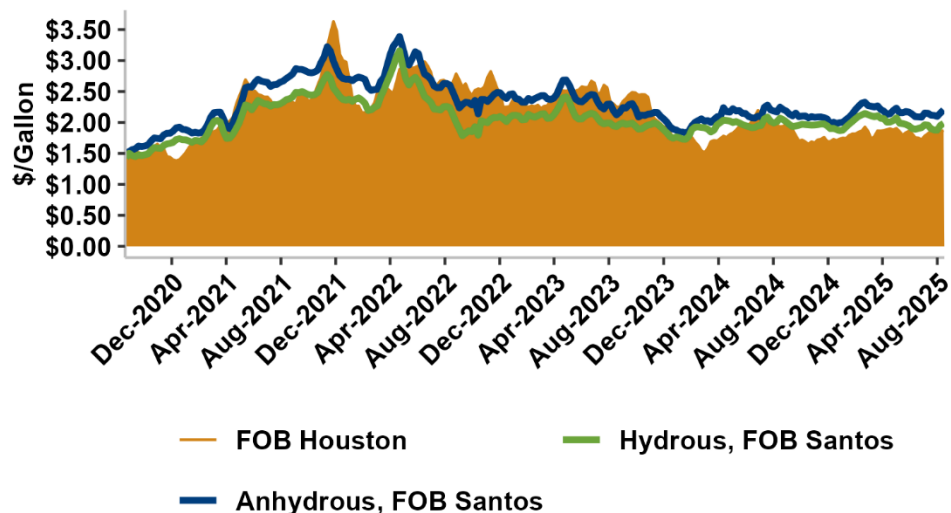

Ethanol as % of Gasoline, FOB U.S. Gulf Prices



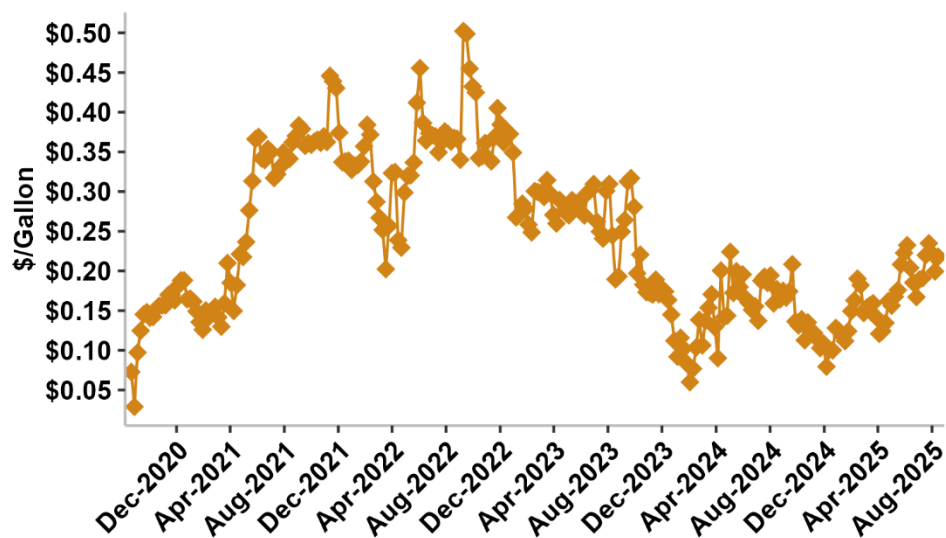

FOB Ethanol Prices, U.S. Gulf and Santos, Brazil



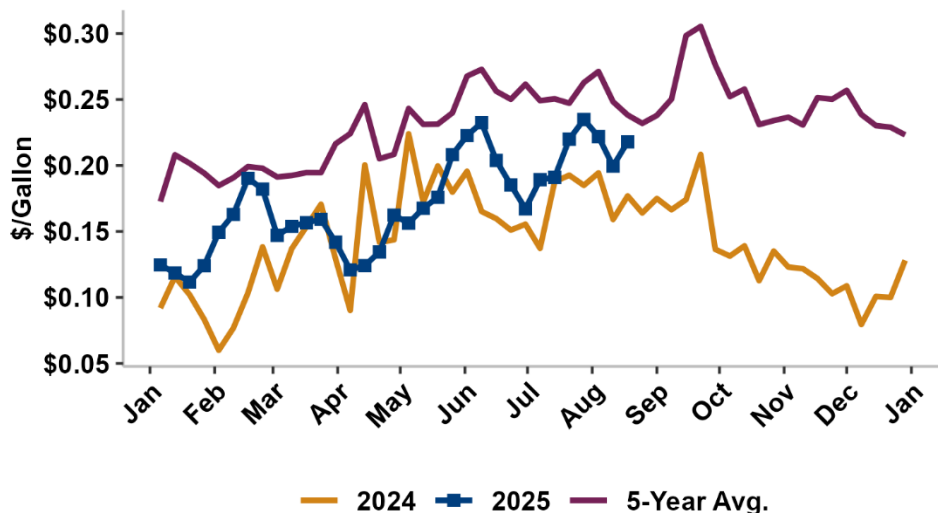

FOB Santos, Brazil Anhydrous - Hydrous Ethanol Spread



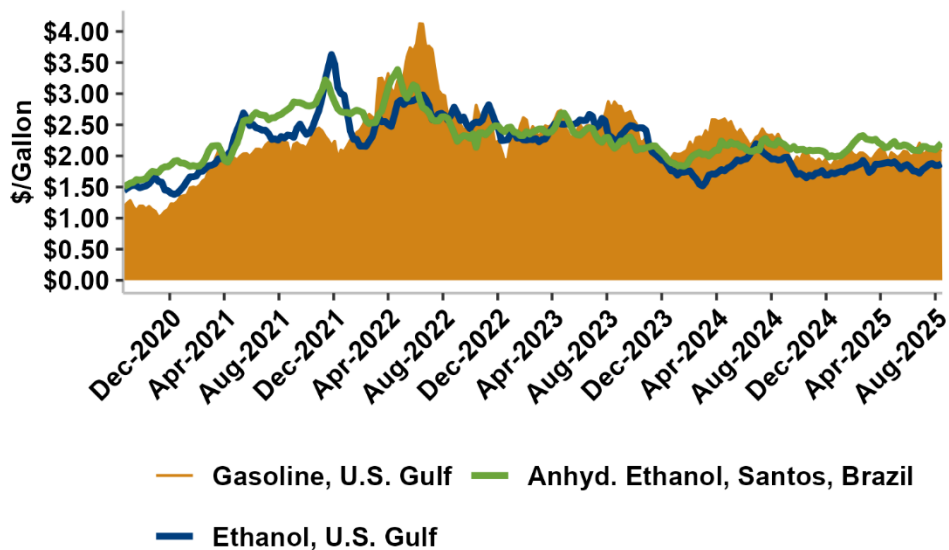

Seasonal Trends in Brazil's Anhydrous - Hydrous Ethanol Spread



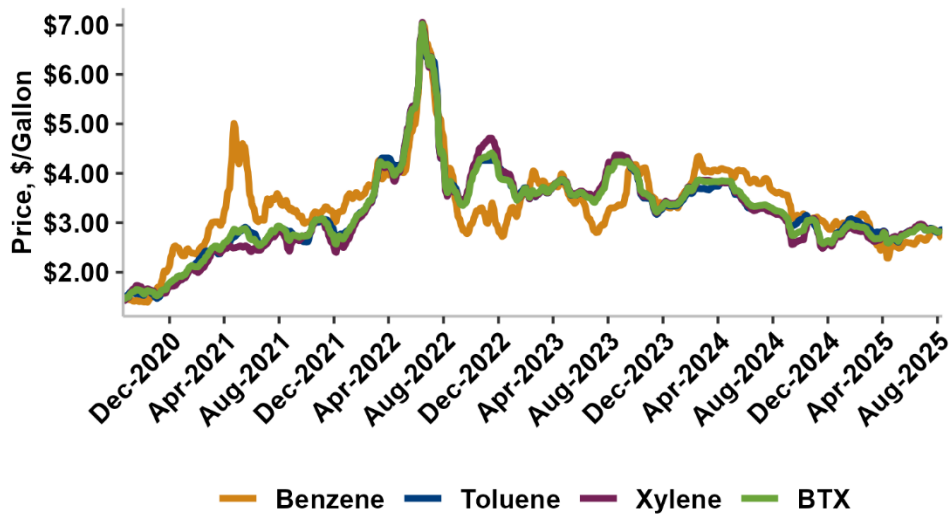

FOB Gasoline and Ethanol Prices



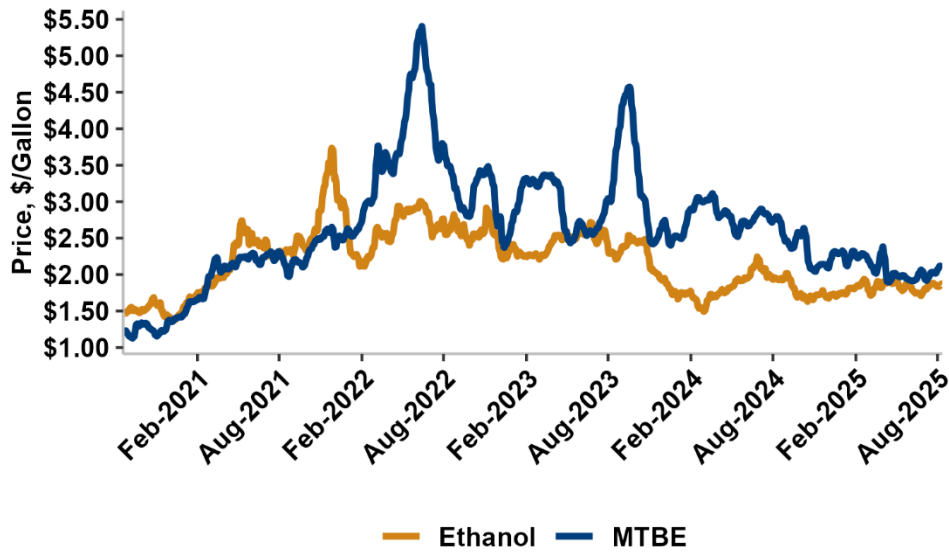

U.S. Benzene, Toluene, and Xylene Prices and Estimated BTX Value



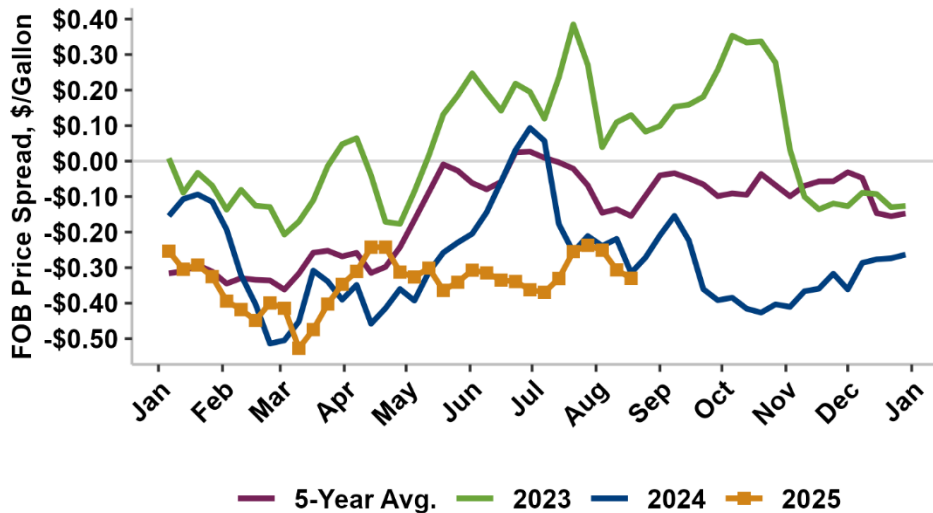

MTBE versus Ethanol Prices, FOB U.S. Gulf



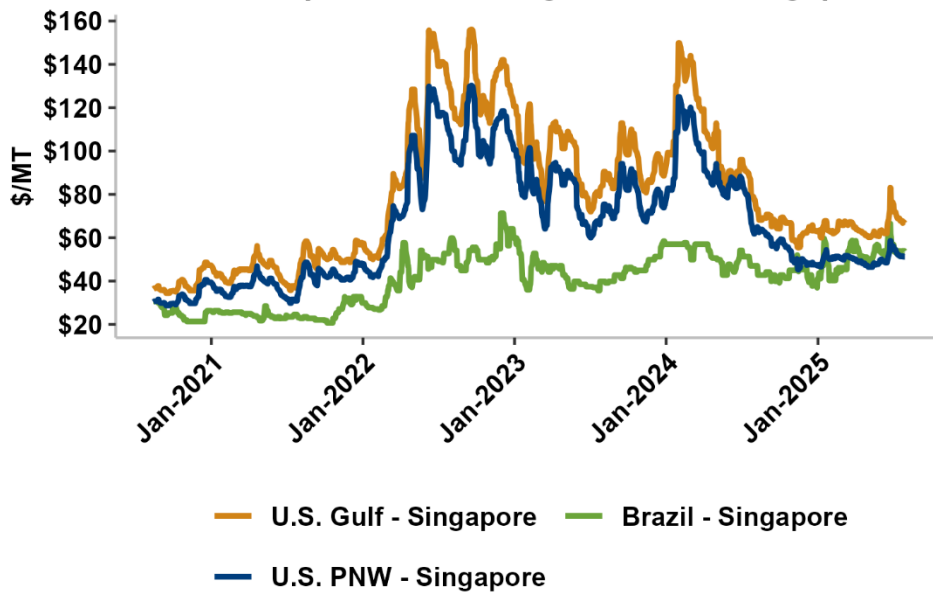

Seasonal Trends in U.S. Gulf - Santos, Brazil Ethanol FOB Price Spreads

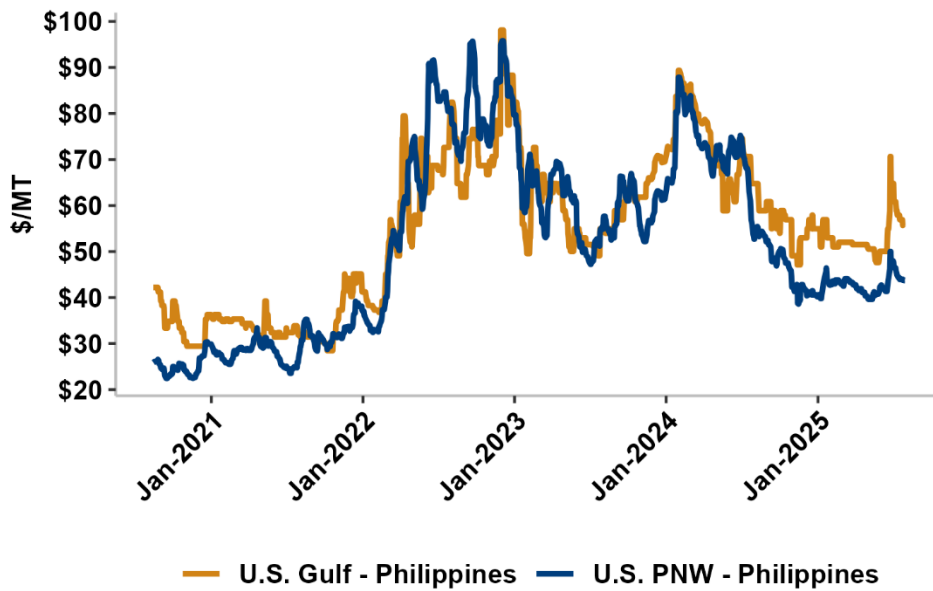

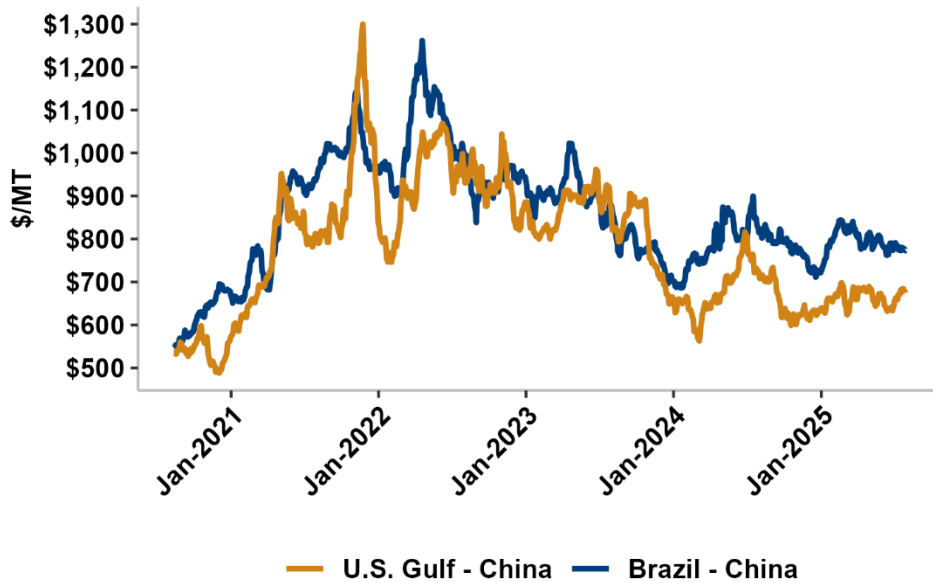
Clean Liquid Tanker Freight Rates to Singapore



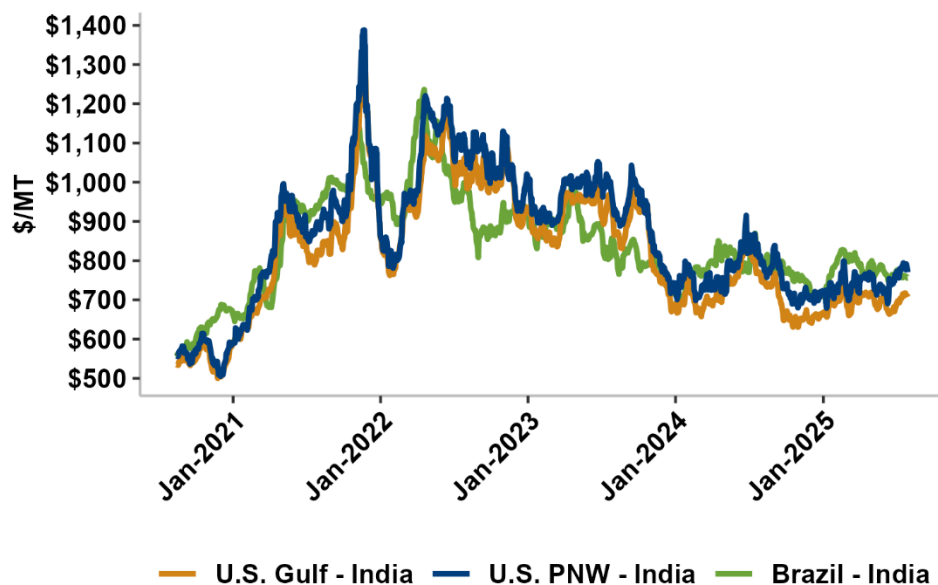
Clean Liquid Tanker Freight Rates to the Philippines



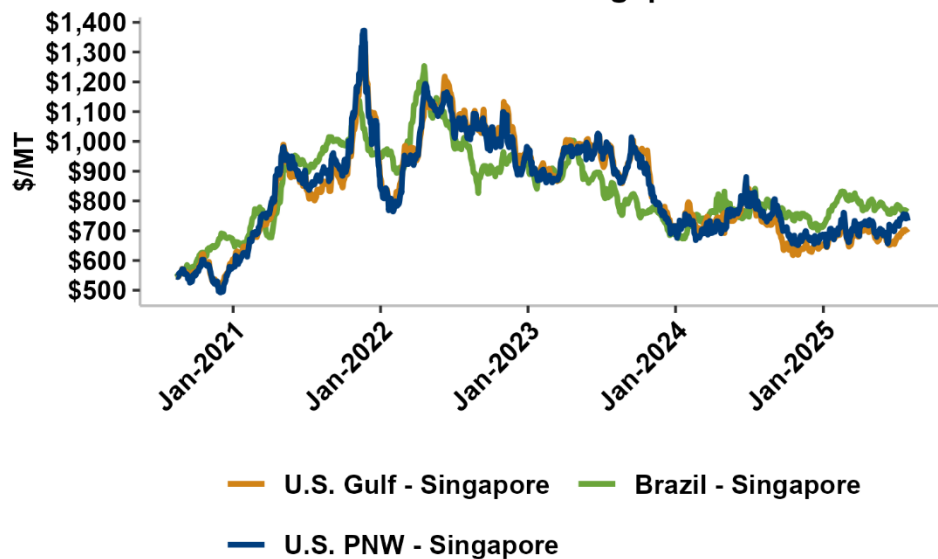
Estimated C&F Prices for Ethanol Delivered to China



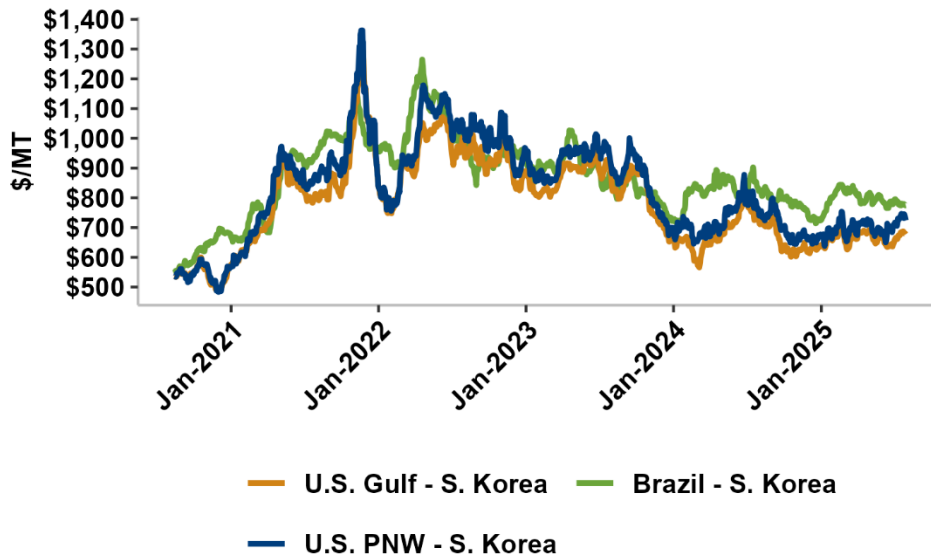
Estimated C&F Prices for Ethanol Delivered to India
